We are pleased to present the report on the Postal Ballot through remote e-voting conducted by Shilpa Medicare Limited ("the Company") seeking the consent of its Members for the Ordinary Resolutions as contained in the Notice of Postal Ballot dated **Tuesday**, **October 07**, **2025**.

I, Santhosh Kumar Gunemoni, Partner, VCAN & Associates, Practicing Company Secretaries, have been appointed as the Scrutinizer by the Board of Directors of the Company pursuant to Section 108, 110 of the Companies Act, 2013("the Act") and read with rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("Management Rules") for the purpose of scrutinising the postal ballot through e-voting in respect of the below-stated resolutions as proposed in the Postal Ballot Notice dated **Tuesday, October 07, 2025**, and I submit my report as under:

### 1. Management Responsibility:

The management is responsible for ensuring compliance under the Act, Management Rules, General Circulars issued by the Ministry of Corporate Affairs (MCA) vide Circular No. 14/2020 dated April 8, 2020, Circular No.17/2020 dated April 13, 2020 20/2020 dated May 5,2020 read with Circular No.22/2020 dated June 15, 2020, Circular No. 33/2020 dated September 28, 2020, Circular No. 39/2020 dated December 31, 2020, Circular No 10/2021 dated June 23, 2021, Circular No 20/2021 dated December 8, 2021, Circular No 3/2022 dated May 5, 2022 and General Circular No. 11/2022 dated December 28, 2022, Circular No. 09/2023 dated September 25, 2023 and 9/2024 dated September 19, 2024 issued by Ministry of Corporate Affairs (MCA), Government of India (hereinafter referred to as "MCA Circulars") and SEBI vide its circulars dated May 12, 2020, January 15, 2021, May 13, 2022, 2023 ,SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July SEBI/HO/CFD/cFDPoD-2/P/CIR/2023/167 dated 7th October, 2023 General Circular No 9/2024 dated September 19, 2024, General Circular No. 3/2025 dated September 22, 2025 and SEBI/HO/CFD/CFD-PoD-2/P/CIR/2024/133 dated 03rd October 2024 (collectively referred to as "SEBI Circulars"), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended ('SEBI Listing Regulations'), Secretarial Standard on General Meetings ('SS-2') issued by the Institute of Company Secretaries of India and any other applicable law, rules and regulations (including any statutory modification(s) or re-enactment(s) thereof, for the time being in force) in respect of postal ballot through remote e-voting.

### 2. Scrutiniser's Responsibility:

My responsibility as the scrutiniser is restricted to scrutinise the e-voting process, in a fair and transparent manner and to prepare scrutinisers report of the votes cast in favour and/or against the resolution stated in the postal ballot notice, based on the reports generated from the e-voting system provided by KFin Technologies Limited ("KFinTech"), which was engaged by the Company for conducting voting through electronic means.

#### 3. Cut-Off Date:

The shareholders of the Company holding shares as of the cut-off date, i.e. **Friday, October 03, 2025**, were entitled to vote on the resolution as contained in the postal ballot notice.

#### 4. Postal Ballot Process:

- a. In terms of the Postal Ballot Notice, the e-voting commenced on Thursday, October 9 2025, at 09:00 a.m. (IST) to Saturday November 8 2025, at 05:00 p.m. (IST), and the e-voting module was blocked by KFinTech thereafter.
- b. The votes cast under e-voting were thereafter unblocked and downloaded on Saturday, November 08, 2025, at 05:17 p.m. (IST) from the portal of KFinTech, and as witnessed by two witnesses, who are not in employment of the Company and/or the KFinTech.
- c. I have Scrutinised and reviewed the remote e-voting based on the data downloaded from the KfinTech e-voting system, at <a href="https://evoting.kfintech.com">https://evoting.kfintech.com</a>.

#### 5. Postal Ballot Result:

After ascertaining the votes cast by remote e-voting, I hereby submit the results as an Annexure- I to this report. Based on combined results, we report that all the resolutions as per the Postal Ballot Notice dated Tuesday, October 07, 2025, stand passed with the requisite majority.

### 6. Custody of the Records:
